Fees: Those spending the night will be charged \$10 per person per night.
The dining hall rents for \$250 per day. If your party is using on the facilities of the

camp for the day and using the dining hall for meals there will be an additional charge of \$4 per person.

The kitchen is \$100 per day, if the equipment is being used to prepare meals.

(We will gladly prepare meals for you and will furnish menus for you to make selection upon request.)

The shelter is \$75 per day.

The pool is only rented until August 30th. It rents for \$225 per day up to two hours. A Red Cross certified lifeguard must be furnished or an additional fee of \$50 per hour will be assessed so that one can be furnished.

Camp is not considered reserved until a deposit and this application is received. No date will be reserved without the deposit.

Damage: Any damage to the facilities or equipment beyond normal usage will be charged to the rental group based on the repair or replacement cost. Failure to leave the grounds/buildings clean will result in a \$150 cleaning fee and will be deducted from the deposit or billed to the organization.

Cancellations: The rental group may cancel this contract up to (30) thirty days before the arrival date above and the \$150 will be fully refunded. Cancellation within (30) thirty days of the scheduled arrival forfeits the deposit unless the camp is re-rented.

The rental group listed above agrees to comply with all the terms and conditions noted herein and on additional pages.

Rental contract (cont)

1. *Subject to limitations below, the Renting Group named on page one hereby assumes all risks of damage or injury in connection with the use of any camp facility or equipment, specifically including but not limited to the lake and swimming pool. SWIM OR BOAT AT YOUR OWN RISK. A duly certified lifeguard, provided by the Renting Group MUST supervise all swimming.*

Unless caused by CBCRC's gross negligence, willful misconduct, or a defect in the facilities, the Renting Group hereby agrees to hold harmless and indemnify CBCRC, its officers, directors and agents, from any and all loss arising out of Renting Group's use of the premises and equipment.

Unless caused by Renting Group's negligence, gross negligence, or intentional misconduct, CBCRC hereby agrees to hold harmless and indemnify Renting Group, its officers, directors, and agents, from any and all loss arising out of CBCRC's operation of the premises and equipment.

2. The Renting Group shall supply all bed linens, blankets, pillows, towels, washcloths, soap, and all other toilet articles for use in the cabins. If the kitchen is rented to prepare meals, pots, pans, dishes, and eating utensils are available for use. The Renting Group agrees to leave the kitchen and any items used, clean before they depart. Food and paper products stored in the pantry, freezer or refrigerator is not to be used unless given permission by the camp director.

3. The following are prohibited on campus: Tobacco products, alcoholic beverages, illegal drugs, guns, firearms, or fireworks. Fires must be confined to the designated Fire Pit area below the nurse's cabin. Do not leave the fire unattended.

4. Sports equipment is available for use by the Rental Group. The Rental Group agrees to return the equipment to the storage area before departure.
